# Absentee ballots challenged in recent election

35 absentee ballots for Shelby Visintin have been called into question in an election challenge. The Ho-Chunk Nation's June 2, 2015 election, where Wilfrid Cleveland won the Ho-Chunk Nation presidency and Douglas Greengrass, Kathy DeCamp, and Shelby Visintin won seats on the Ho-Chunk Nation Legislature, is being challenged by District 4, Seat 1 candidate Muriel Whiteagle-Lee.

Whiteagle-Lee lost the June 2 election by 24 votes to Shelby Visintin. Visintin received 35 absentee ballots, while Whiteagle-Lee received 9 absentee ballots.

Whiteagle-Lee filed a complaint against the Ho-Chunk Nation Election Board Chairperson and Ho-Chunk Nation Election Board et al on June 15. The two parties were in court for a pretrial hearing on June 22. Whiteagle-Lee's attorney James Ritland amended the complaint filing to Ho-Chunk Nation Election Board Chairperson Bridgette Schultz and Ho-Chunk Nation Election Board. Michelle Greendeer-Rave was pres-

ent as the Election Board's attorney, along with member of the Election Board.

The two parties met again the very next day, June 23. Judge JoAnn Jones opened up the June 23 proceedings by saying, "I want to remind you to show respect in the courtroom. Keep your people in line."

Judge Jones continued, "The purpose of today's hearing is to address motions from the June 22 hearing. The first motion is a Motion to Dismiss."

Greendeer-Rave started by saying, "This is a frivolous claim. What law was violated? The allowance of absentee ballots is not a violation. The plaintiff knows this. My clients are immune through sovereign immunity. The Election Board conducted business as usual when they certified the election results. How did they step outside their scope of authority? There is no concrete evidence. My clients have to miss work to be here. They took an oath to serve on the Election Board. The Election Code was followed."

Greendeer-Rave continued, "Absentee ballots outlined in the Election Code doesn't require use of the U.S. Postal Service. There wasn't any ballot stuffing. These votes should not be discounted. The plaintiff said she doesn't like the Election Code. Just because they don't like it doesn't merit a court case."

Attorney Ritland gave a rebuttal.

"Proof of clear and convincing evidence is for the trial. Not a pre-trial motion hearing. This Motion to Dismiss is a premature motion. We have a highly unusual case of 35 Ho-Chunk members' absentee ballots submitted by the candidate's mom," said Ritland.

Ritland continued, "We want to look at these envelopes. We want to know if there was one notary for all

35 absentee ballots, or if there were 35 different notaries. We also want to know how they got addresses for these voters. Did these voters get talked into voting?"

Ritland said the candidate or her mother knows these people, whose names were revealed at the Election Board meeting when the election results were certified, but doesn't know where they live.

"We'll find out in the trial, or during pre-trial discovery. If 35 ballots are thrown out, my client wins the election. This grants standing for a trial. The violation of the Election Code appears in Chapter 2, Section 6. It states absentee ballots are usually requested prior to or 10 days prior to an election. Any tribal member can challenge an election if a violation occurs or it is an unfair election. This court should listen to a trial," said Ritland.

Attorney Ritland also present a Motion to invalidate the certified election results. Ritland said District 4 has only one seat, but certified election results lists the race as District 4, Seat 2 election occurred.

Attorney Greendeer-Rave said, "Yesterday, we were unaware of the typo. This motion was untimely filed, as it did not occur 10 days from the certification of the election results."

Automated Election Services is the service provider who supplies voting machines and template documents to the Ho-Chunk Nation Election Board.

"Our service provider took full responsibility for the error. Our representative, Tim Klooppel, signed an affidavit. We submit this as Ex-

hibit D. The Election Board Notice of Election from November 24, 2014 listed the election for District 4, Seat 1. We argue and object to invalidating this election," said Greendeer-Rave.

"The election results certified are wrong and should be invalid. The Election Board met again, and hasn't made a correction," said Ritland.

Attorney Ritland made a verbal Motion of Discovery for Absentee ballots and envelopes. Judge Jones said that must also be written for the court's records.

"I have something to ask both of you about the Ho-Chunk Nation Constitution's Article 8, Section 7 and the Ho-Chunk Nation Rules of Civil Procedure Section 17B. What is your interpretation of this law," asked Judge Jones.

Greendeer-Rave said, "If the court uses strict scrutiny of reading the Ho-Chunk Nation Constitution, the election results were certified on June 3. 10 days after would be June 12. The Department of Justice was

served on June 15. The Rules of Civil Procedure states that computation of time is stamp date of filing. We ask the court to dismiss this case."

"The next working day is when computation of time begins. We don't count the day the election results are certified. June 3 would begin the computation of time for meeting 10 days requirement. June 13 is a Saturday and the court is not open. The next working day is June 15. These 2 compatible documents clearly show the complaint was timely filed," said Ritland.

Judge Jones concluded, "An order will be issued as soon as it is done."

Greendeer's wife, Chris Munson, gave a thank you speech, talked


about her husband's attributes and political performances towards the Ho-Chunk Nation.

# Ho-Chunk Nation sponsors Task Force for Drug-Free Communities workshop

In an effort to join health care workers, law enforcement personnel, social workers, and government officials in a discussion of the drug abuse problem in the area, the Ho-Chunk Nation sponsored a drug problem recognition training event on Tuesday, June 9, at Comfort Inn, Black River Falls.

The training was organized by the "Task Force for Drug-Free Communities," which includes partner agencies and programs through both the Ho-Chunk Nation and Jackson County.

At the beginning of the event, members of Ho-Chunk Social Services and community leaders stated the prevalence of drug use in the area and how the problem has become worse. In addition to drug overdoses becoming more common, more drug-addicted babies are being born from mothers who are using drugs.

Special Agent Bryan Kastelic from the Wisconsin Department of Justice gave a presentation concerning the current problems and trends in drug use in Wisconsin and how it has been escalating in recent years.

The event was important because of the significant increase of overdoses and drug abuse within the Jackson County area. There have been four overdose deaths, related to heroin, this year alone and Narcan use was at 2-3 times per month up (estimated). In addition, both the Jackson County Sheriff's Department and the Black River Falls Police Department have been receiving reports regarding needles being found in the community.

The participants at the training represented various agencies, including but not limited to: Ho-Chunk Nation Child and Family Services representatives, Ho-Chunk Nation Community Health Reports and Community Health Nurses, Ho-Chunk Housing, Ho-Chunk AODA and Behavioral Health, Black River Falls EMS, Black River Falls Police Department, Jackson County District Attorney's Office, Jackson County Treatment Court staff, Jackson County Public Health, Jackson County Department of Health and Human Services (Mental Health-AODA Program), Birth to Three, County Board representatives, City of Black River Falls representatives, Black River Falls Parks staff, Boys and Girls Club of Jackson County, Probation and Parole, Black River Memorial Hospital staff, Ho-Chunk Nation Police Department, UW-Extension,



**Professionals from throughout the area attended the Task Force for Drug-Free Communities workshop, including people working with law enforcement, health-care, social services, housing, county boards, youth organizations, and mental health services.**

Together for Jackson County Kids, Lutheran Social Services staff.

Some of the comments from the attendees were that, while the information was great, it

scared them to think that these types of things are going on in the community. There seemed to be a great hope that the Nation and the County can continue to collaborate to address

this issue. For the second half of the day, workgroups were held that led to next steps for what can be done.

# Ho-Chunk Nation and Wisconsin Indian Education Association form partnership to hold Wisconsin SEED Institute

The Ho-Chunk Nation and the Wisconsin Indian Education Association, in partnership with the National SEED Project, held the inaugural Wisconsin SEED Institute at the Green Lake Conference Center from June 14-19. SEED stands for Seeking Educational Equity and Diversity and is based out of the Wellesley Center for Women, Wellesley College, in Massachusetts. According to its website, "SEED is a peer-led professional development program that promotes change through self-reflection and interpersonal dialogue and builds capacity for more equitable curriculum, campuses, and communities."

Entering its 29th year nationally, SEED has been a transformative experience for many. SEED leaders facilitate a group of their colleagues in experiential, interactive exercises, and conversations often include the use of films and readings in its intentionally structured group conversations, to create safe and inclusive learning environments. One of its stated goals is to provide an avenue for "ongoing constructive conversation"

around difference with "no blame, no shame, no guilt." Participants are recognized for having their own experiences, are at different places in their learning, and will undertake this effort of learning and understanding as a lifelong endeavor.

The Ho-Chunk Nation has participated with SEED for the last four years, with Michelle Cloud, Barbara Blackdeer-Mackenzie and Adrienne Thunder all having received the national SEED training, and has held SEED seminars in the Black River Falls School District in that time as part of the Culturally Relevant Teaching workgroup. On the Nation's side of the partnership, Michelle Cloud and Barbara Blackdeer-Mackenzie led the planning effort for this inaugural Institute along with Brenda Flyswithawks and Emmy Howe, National SEED Co-Directors. The goal for the Wisconsin SEED Institute is to train facilitators who will hold SEED seminars in their school districts or home communities.

Participants in the Wisconsin SEED Institute have diverse roles in education, from administrators, to school board members, to student

services staff. The Institute focused on various forms of privilege and systems of oppression by sharing individuals' experiences (knowledge of the selves) and resources provided by presenters (knowledge on the shelves), including Peggy McIntosh, nationally known for her work

on white privilege and Phase Theory (representing how systemic oppression functions). Each of the participants is encouraged to share what they have learned and the resources provided in a year-long SEED seminar at their own school or district. If you have questions about

## NOTICE AND RULES OF SPECIAL ELECTION FRIDAY, JULY 10, 2015

### Supreme Court Associate Justice 2

Notice is hereby served to all eligible voters of Ho-Chunk Nation. The Ho-Chunk Nation is calling a Special Election, which will be held due to the resignation of Supreme Court Associate Justice 2, Todd R. Matha, who won the seat in the Special Election Supreme Court Chief Justice held on Saturday, April 25, 2015. The Ho-Chunk Nation Election Board in accordance with the Constitution of the Ho-Chunk Nation will conduct a Special Election. ARTICLE IX – ELECTIONS and the Election Code 2 HCC Sec. 6, states in relevant part:

### NOMINATIONS OF CANDIDATES

The official candidacy forms may be obtained from the Election Board Members or the Election Board Office. A candidate for elective office shall submit an Official Nomination Petition, Declaration of Candidacy and a \$5.00 filing fee by hand delivery or U.S. Mail to the Election Board office before the close of the nomination period on Thursday, June 18, 2015. ORIGINAL FORMS MUST BE SUBMITTED. FILING BY FAX OR COPIES WILL NOT BE ACCEPTABLE.

### ELIGIBLE VOTERS:

Any enrolled member of the Ho-Chunk Nation who is at least eighteen (18) years old and who has resided in their respective district for at least three (3) months. See Election Board Code Sec. 11 (6) Residency Requirement for Voters

### REGISTRATION

Each person seeking to vote must register at the polling place by showing identification before receiving an Official Ballot. If a person cannot write, that person must sign his/her name with a mark before two (2) witnesses. A Ho-Chunk translator will be available to assist any tribal member who requests assistance.

### ELIGIBILITY DISPUTES:

Any individual whose name does not appear on the eligible voters list can claim the right to vote by presenting a written challenge to the Election Board. Any eligible voter may challenge the eligibility of an individual's name appearing on the eligible voters list by presenting a written challenge to the Election Board. Challenges must be received at the Election Office prior to 4:30 P.M. on Saturday, June 20, 2015. Such claims or challenges may be hand-delivered, faxed or mailed to:

The Election Board shall rule on all written challenges to the eligible voters list immediately after the close of the challenge period. The Election Board decision shall be final.

### ABSENTEE VOTING:

A voter may vote by absentee ballot provided the Election Board receives the absentee ballot request in writing no later than **Tuesday, June 30, 2015 by 4:00 P.M.** See Election Board Code, sec. 13 a. i. Absentee Voting Permitted. Requests MUST INCLUDE the eligible voter's name printed or typed (with signature), physical address where the ballot will be delivered (we use UPS Next Day Air – UPS Next Day Air will not deliver to a P.O. Box), daytime telephone number and enrollment number.

### Absentee Ballots must be received before 7:00 P.M. on Friday, July 10, 2015.

Absentee ballots may be returned by overnight mail, so they may be received at the Election Board Office or the polling places prior to the Election Day. **NOTE THAT FEDEX and UPS NEXT DAY AIR DOES NOT DELIVER IN BLACK RIVER FALLS ON SATURDAYS.**

### POSTING ELECTION RESULTS:

The Election Board shall certify and post the official election results within three (3) days after the date of election.

### CONTESTING OF ELECTION RESULTS:

Any member of the Ho-Chunk Nation may challenge the results of any election results within ten (10) days after the Election Board certifies the results. The Trial Court shall hear and decide a challenge to any election within Twenty (20) days after the challenge is filed in the Trial Court. See HCN Constitution Article VIII, Election, Sec. 7, Challenges of Election Results. Election Code Sec. 18 (a) Challenges to the Election Results.

### ELECTIONEERING:

There shall be no electioneering within fifty (50) feet of any polling places.

# Departments asked for input in upcoming Ho-Chunk census

The process of conducting a new Ho-Chunk census is a little closer to being launched later this year.

Kevin Klingbeil, managing director of Big Water Consulting, came to the Ho-Chunk Nation Executive Building on Monday, June 8, to discuss the upcoming census and hear from department directors about what they would like to see on the census forms.

Ho-Chunk Nation department managers have been asked to become involved because certain information is needed for a particular department so that specific needs can be met.

“The last completed census was 20 years ago,” said Pine Giroux, one the leaders of the census in the Ho-Chunk Nation Planning Department. “The Ho-Chunk Constitution mandates that we conduct a census every 10 years. There was one attempt 10 years ago, but that failed.”

This new census will not only collect the information to replace and update the 1994 census but will also broaden its focus to collect information specifically targeted to help tribal programs make more informed decisions and strengthen tribal grant applications, Klingbeil said.

The Ho-Chunk Division of Planning and Development recently hired Big Water Consulting, specialists in tribal data collection, to serve as the

General Coordinator of the project.

“The goal of the census is to gather information about all enrolled members of the Ho-Chunk Nation. All enrolled members age 18 or older will receive a questionnaire,” Klingbeil said.

According to the timeline provided by Klingbeil, planning and preparation of the census will take until the latter half of July. Survey design and testing will be conducted until early September, during which interviews, hiring and training will take place of the survey workers.

At the beginning of October, the questionnaires will be sent out to Ho-Chunk members. Also, the same questions will be posted online, if a respondent wishes to file electronically.

“We’d like to have them available at General Council,” said Angie Greengrass of the Planning Department. “We want them to know it’s coming and not to be afraid. None of the information will be shared with any other entity.”

People will have three weeks to either mail the answers back, or to complete the process online. If no response has been received, local polling workers will follow-up by calling those individuals.

From November to February, local workers will conduct in-person follow-up visits and mapping, which would include door-to-door visits. The compilation of the data,

report production and presentations are planned from February through March.

To have a true picture of Ho-Chunk demographics, it is important to have as many responses to the census as possible.

“We want to make sure that we have the highest response,” said Heather Rebedew of the Planning Department. “We would like 100 percent.”

The data collected will help with planning Ho-Chunk services, redistricting and applying for grants.

“In order to make sure the census questionnaire will

collect the information the Nation wants and needs, Big Water is currently talking with tribal leaders and program managers and staff to learn about what data each department already has and would like to have,” Klingbeil said.

“Many grant applications across all programs require information about the age, income and veteran status of the population that would be served in order to document the need and eligibility for the award, so expect questions about those topics,” he said.

“There will also likely be some questions aimed to identify barriers to the use of some

tribal programs and some questions targeted specifically to members living in each of the five Districts.”

There are upcoming promotional events connected to the project, including a contest to design a new logo for the HCN Census, so be on the lookout for more information as it becomes available.

# Ribbon-cutting ceremony held for new Veteran Supportive Housing

A ribbon-cutting ceremony for the new Veteran Supportive Housing unit on Thursday, June 18, officially opened the doors for veterans to have a roof over their heads and

the support they need to get through the difficult times.

"This is one of the most important things done in the last few years," said Ho-Chunk Nation President Jon Greendeer. "This is one of the only times I've been part of

both the groundbreaking and ribbon-cutting."

The housing arrangement is a unique in the fact that residents can receive in-house services, such as healthcare, mental healthcare, TERO, Life Skills, treatment for PTSD, and anything else to make life more livable, Greendeer said.

"This is a test on how well we work together, working toward a shared goal," he said. "This is not a humble event. People are watching this nationwide."

Present at the event were Wisconsin State Veterans Secretary John Scocos, and U.S. Sen. Tammy Baldwin's staff representative John Medinger. Also present was Monroe County Veterans' Service Officer Margaret "Muggs" Garvin.

Scocos said the newly-completed Veterans Housing will be a model for the future.

Ho-Chunk Housing and Community Development Project Director Neil Whitegull said that Ho-Chunk Nation Vice President Heather Cloud made a motion two years ago for the project. But it was 12 years ago when Jim Greendeer offered the suggestion of creating such a housing complex and a HUD per diem grant was obtained.

The land was purchased in 2004 with a lease applied for in 2006, when the Ho-Chunk Nation set aside the land for the project.

Groundbreaking for the Veteran Supportive Housing occurred on June 4, 2014.

"Nearly all of the project was Ho-Chunk Nation funded, except for a \$50,000 Enterprise Foundation grant," Whitegull said.

Whitegull said the supportive housing will "provide housing for people who need the help. Housing comes first and the rest will follow."

# Green Bay pool project receives help from Ho-Chunk Nation

The Ho-Chunk Nation made a donation of \$100,000 to the Friends of Colburn Pool on Wednesday, June 17, to help save a Green Bay neighborhood pool.

It started about four years ago when city officials were discussing the closure of the pool because standards were not up to date.

“That’s when I started to gather petition signatures to keep it open,” said Olivia Crooks, a self-described “pool rat” who spend all her summer time at the pool. “I looked at what it would take to keep it open, raised money to hire a contractor to give an estimate on the repairs, and it took off from there.”

Olivia said all the work “is definitely worth it.”

With the donation from the Ho-Chunk Nation, the project has received a total of \$645,000. One of the donations was from a prominent couple in Green Bay, Bernie and Alyce Dahlin, who contributed \$300,000 and, consequently, will half the naming rights for the pool.

After the check-passing ceremony, a reception and meal was held in the Ho-Chunk Nation branch office.

“By the end of the pool season, we hope to secure bonding rights with the city,” said Lori Crooks of the Friends

of Colburn Pool organization. “Then we can start construction of the new pool.”

The new pool will be Olympic size, with eight lanes.

The city of Green Bay will pay for \$3.5 million of the renovations if the group raises \$1 million. The Friends of Colburn Pool have raised 60 percent of their goal.

With the donation, the Ho-Chunk Nation has the naming rights for the community room, which will be open to the public on a year-round basis. The Nation will have the ability to decorate the room however the members wish. One of the suggestions being considered is to provide a history of the Ho-Chunk people within the room.

Pam Noll, a Green Bay resident and mother frequently visits Colburn Pool because she likes the atmosphere more than the two other public pools in the city.

“I’ve been coming here since I was 5 – so that’s been 23 years,” she said. “It’s my home away from home.”

The other pools are on the other side of the city and have many other activities, such as slides and sand area and a rock climbing wall. Noll said those activities are distractions and she only wants to come to a pool for swimming.

“The initiative was brought forth by

the community,” said Area III Rep. Darren Brinegar. “The tribal members in the area will benefit greatly. It’s good for the community.”

“It’s a great opportunity to build relations with the community and especially for the kids and future generations,” said Ho-Chunk Nation Vice President Heather Cloud.

Green Bay Packers Director of Public Affairs Aaron Popkey was present for the check passing ceremony. He stated that the Packers organization has donated \$5,000 to the Colburn Pool project as well.

“We’ve supported the project from the beginning,” he said. “It’s a wonderful resource for the neighborhood. What’s special is that this pool is right down the street from Lambeau Field. It’s a resource in the

neighborhood, so we need to support it financially. Likewise, the Ho-Chunk Nation’s support is fantastic.”


Ho-Chunk Nation President Jon Greendeer said the philosophy behind any actions is to leave something better for the next generation.

“Today’s a good chance to witness exactly that,” Greendeer said. “We also get to witness the work of a lot of people.”

“Olivia did something great, which shows her selflessness,” he said. “We all work together for something to benefit other people. There are a lot of \$100,000 good causes out there, but we have to look at where it is spent best. This is something that brings families together. This is a healthy option, which comes back tenfold. This is something that promotes being active and being outdoors.”

With so many negative influences on children these days, it’s good to be able to provide a resource that will allow children to have fun in a great social environment.

“Small changes point people in positive directions,” Greendeer said. “People need to surround themselves with a positive source.”



Plans for the new pool are on display at the Ho-Chunk District Office in Green Bay. Of special notice is the plan for a Community Room, which will be named for the Ho-Chunk Nation and will be open year-round for family activities.




The present Colburn Pool has been inspected and deemed as needing repairs. So, the present pool will be removed and replaced with an eight-lane Olympic size pool instead.





# Smoke clearing for casino is a first

This decision is based on data collected from a smoking survey conducted with guests which began last November. Based on the results, Ho-Chunk Gaming Madison will continue to be an industry leader by becoming the first casino in the state to offer a 100% smoke-free gaming facility. “We’re excited to offer our guests and employees a completely smoke-free environment,” said Daniel Brown, Executive Manager, Ho-Chunk Gaming Madison.

The Wisconsin Statewide Smoke-Free Air Law went into effect in July, 2010 and requires restaurants, bars and entertainment venues to be smoke-free. However, as the Ho-Chunk Nation is a sovereign nation which is self-governing on its tribal lands, the Ho-Chunk Nation exercised their inherent sovereignty and made the transition to a smoke-free environment completely of their own volition. “We believe that we are among the first business which is choosing to do this on our own, rather than being publicly mandated to do so,” stated Brown. This bold move leads the way for all casinos in Wisconsin to consider going completely smoke-free as it follows this mainstream trend.



Ho-Chunk will offer a separate smoking area for smokers apart from the current facility so that the smoke will not permeate into the building,

in addition to allowing the use of electronic cigarettes. “We still believe in providing areas to accommodate all of our guests, but, want to assure

the existing building will be 100% smoke-free,” expressed Brown.

# Board debates future of Ho-Chunk land

The Juneau County Board of Supervisors debated the future of a parcel of land owned by the Ho-Chunk Nation that brings in \$10,000 annually in tax money at its monthly meeting on Tuesday at the Juneau County Courthouse.

The land in question is a 272-acre mix of farmland and woodland located in both the Town of Lyndon and the Town of Kildare. On Tuesday, the board proposed a resolution that would end county opposition to the trust status regarding the parcel of land.

Darren Brinegar, District III Legislator representing the Ho-Chunk Nation, was at the meeting to answer questions about the proposed resolution. Several board members had concerns about how the county will recoup the loss of the \$10,000 annual tax payout for the property.

“At this point, we have a legal team that is preparing a resolution that would continue to bring money to Juneau County,” Brinegar said. “We have spent a considerable amount of money in the county and we look to do more here. We pride ourselves on being good neighbors.”

Based on a 2010 agreement between the county and the Ho-Chunk Nation, continued contributions from the Nation would far outweigh the tax value of the trust. Brinegar said the Nation plans to meet next Tuesday to discuss plans that would fund a bridge project and a boat launch in the

county that could cost \$161,000.

“In order for the Nation to purchase more land in the county, we would have to develop a resolution and that’s a long process that doesn’t take months, but years,” Brinegar said.

A question of how the county would reimburse the townships affected by the loss of tax revenue was posed at Tuesday’s meeting. One board member asked how losing \$10,000 would affect local school districts in Mauston and Wisconsin Dells. The board requested tabling the resolution for July’s meeting until it has more information on how the tax revenue will be replaced.

“To me, it’s a no-brainer to approve it,” said board chairman Alan Peterson. “But, I only have one vote.”

Litigation against Hoffman Construction

The board approved a \$35,000 settlement to three county residents in a lawsuit against Hoffman Construction Company on Tuesday.

According to a report, three homes received significant damage after blasting was done during the County Highway O reconstruction project. While the board agreed to pay the settlement for damages, several board members voiced displeasure with Hoffman Construction Company, with one member saying the county should “blackball” the company from any future construction projects.






