## Family Wellness Retreat speakers focus on good choices and the power of positive thinking

Fresh air and nature greeted participants in this year's Family Wellness Retreat.

The annual Family Wellness Retreat again was held at the Champion Resort in Galesville, where it was held for the first time last year. It was held from Wednesday, July 22, through Thursday, July 23.

This year, 311 people attended the event, according to Jackie Moen-Kadlec of Ho-Chunk Nation Department of Social Services.

Each year, the organizing staff selects activities and speakers who will give inspiration to the participants and to promote good, healthy family activities.

Main speakers for the adult session included Lani Blackdeer, whose daughter, Louella, was killed in an accident by a drunk driver; and Tamara Oman and Melissa Christensen, two women who served time in prison and have turned her lives

around.

Also, former Green Bay Packer players Gilbert Brown, William Henderson and Santana Dotson offered a morning inspirational session to the youth and again offered a family session in the afternoon on Thursday.

Lani Blackdeer spoke about life choices and the story of her daughter, Louella, who was killed by a drunk driver.

"Life is full of choices," Lani said.

Louella was her youngest, who was very stubborn, independent and struggling with choices of alcohol skipping school. She worked with teachers.

Louella continued to make choices taking her down the wrong roads and it got worse.

"I didn't know what to do," she said. "I couldn't get through to her."

She said she tried sports, but, while her sisters were good with sports involving

balls, Louella was rather clumsy and uncoordinated. Then, she went out for the cross-country team and was enjoying it.

"Running - she could do on her own," Lani said. "In 1999, at the beginning of the school year, she was running and training every day."

Then one day she was running alongside the road when Irwin Begay was driving by and noticed Louella. He stopped to talk to her.

Irwin said he was stationed in Hawaii and he competed in the Honolulu Marathon. He said he had a vision of Native Americans competing at the event with four flags present.

Louella came home and told her mother about the encounter and said that a man in white van wanted to take her to Hawaii. She was shocked until Irwin showed up at her door. He offered his idea of taking a team of native runners to compete in Hawaii. Lani was onboard with the idea and offered to help.

The first meeting had 20 youth present. They soon learned that they had to participate in four months of training, six days a week and that parent participation was mandatory. Those initial 20 runners soon dwindled down to six. Those six runners went on to Hawaii to compete in the marathon.

"The changes in those runners was unbelievable. Irwin would have the stand perfectly straight in line. He taught them respect. They learned a lot in four months of training," Lani said. "It changed Louella. She went to high school with goals she never had before. Things were going pretty good."

In spring, Louella began seeing a young man and they would help each other with homework. Then one day they made plans to go to



the prom at school. Louella had a curfew of 2 a.m., but she came back home at midnight and asked her mother if she could attend a party that was going on that night. She assured her mother there would be no drinking and there were chaperones at the party.

Lani agreed and went back to bed.

She didn't think any more about it until she woke up and noticed a police car outside the house. The sheriff, deputy and coroner were at the door and asked if Louella was home. Lani checked and saw that Louella was not in her bed.

She was told there was an accident and they needed to identify who was in the car. She was told that a fisherman was at Lake Arbutus during opening day, had been drinking and was heading back home to Marshfield when he crossed the centerline and hit a car head-on.

didn't allow myself to get angry."

She said she was so lost and upset, that one of her daughters had to take over the household chores.

But now Irwin said he wants to revive the marathon runners for another season, called Runners Against Drunk Driving or RADD for short.

"It keeps Louella's story alive," she said. "I believe it brought Louella back to us."

Through the years, Lani

# Making the case for an independent Department of Veterans Affairs

I fully appreciate all who work diligently for veterans throughout the Ho-Chunk Nation. On July 23, 2015, the HCN Legislature took up a long standing issue of the tribal veterans office needing autonomy. The item was placed on the Legislative agenda with the intent of addressing issues and concerns of many Ho-Chunk veterans. The Legislature offered a resolution establishing the Department of Veterans Affairs. This would be a promotion from its current status as a division within the Department of Heritage Preservation.

Why would we rather have a Department than a division? An executive director has access to a plethora of resources and proper decision making authority. An executive director will be made available to oversee all operations. At the division level, there is less flexibility in obtaining and utilizing resources, such as personnel and budget.

Currently, programs and services dedicated to veterans are housed within several different departments and divisions. We need to have

one place that a veteran can reach out and receive the support of the Nation. We need advocates that will help our veterans cut through the red tape of the many departments. We need our veterans to bring their teachings and experiences back to the rest of the tribe.

My vision of a Department of Veterans Affairs is an agency that will develop strong working relationships with the Legislative, Executive, and Judicial branches. The agency will be comprised completely of veterans, with oversight by veterans. This department will operate daily to further the position of veterans around the tribe and in our communities. They wouldn't be replicating services available elsewhere but would supplement state and federal resources with tribe-specific resources and events.

I am urging all veterans to participate in the conception and all non-veteran tribal members to support the autonomy in a Department of Veterans Affairs.

# Mitchell Red Cloud Jr. mural unveiled

The Mitchell Red Cloud Jr. mural was unveiled on Saturday, July 4, at the Andrew Blackhawk Memorial Pow Wow Grounds.

Members of the Color Guard began the ceremony, with speakers telling about the significance of the occasion. Present was the artist of the mural, Susan Sampson.

Plans are to permanently display the mural at the Jackson County Historical Society Building in downtown Black River Falls.

Mitchell Red Cloud, Jr. was a Marine in the United States Marine Corps during World War II, and later a soldier in the United States Army during the Korean War. Corporal Red Cloud posthumously received the Medal of Honor for his ac-

tions near Chonghyon, North Pyongan Province, North Korea on November 5, 1950.

Born in Hatfield, Wisconsin, Red Cloud, a Ho-Chunk Native American, dropped out of high school to enlist in the US Marines during World War II.

During the Korean War, Red Cloud singlehandedly held off the Chinese forces despite being shot eight times, at one point ordering his men to tie him to a tree because he was too weak to stand by himself. His company found him the next morning, surrounded by dead Chinese troops. He was credited with alerting his company to the ambush and saving them from being overrun. For these actions, he was posthumously awarded the Medal of Honor.

They talked about leadership, and about never to give up and follow your dreams to the youth there. It was very inspirational.

Gilbert Brown is from Detroit, Michigan. He went to University of Kansas, and from there he went into the NFL. He was drafted by Minnesota, but he never play a game for them. Then, he went over to the Green Bay Packers and play defensive line, nose tackle. He's been playing football since he was in the 9th grade.

He played in the NFL for 11 years all for the Packers. He talked about how he sustained many, many injuries. "Football... Football is a violent sport. It really catches up with you later on in life," says Brown. "But, if I could do it all over again, I would."

"I see them as my brothers," he commented. "Family."

Now, He has four kids. Three boys, one girl. Their names all start with J's. Jamal, Jaida, Jesse, and Jemiah.

Santana Dotson is from New Orleans, LA. He moved from there to Houston, TX when he was 13 years old. He went to Baylor Univer-

sity. While at Baylor, Dotson was voted All-American in 1991. He won the 1992 NFL Defensive Rookie of the Year with the Tampa Bay Buccaneers and played in two Super Bowls with the Green Bay Packers. His position was defensive end.

"It was a great career overall. You know, you enjoy those moments. What I think that sticks out more than anything is just the camaraderie of the locker room at the time; kind of the band of brothers' aspect and everybody all for one, one for all vitality that we had," says Dotson

"I didn't like football,"

mentions William Henderson. "I loved it." Henderson attended Thomas Dale High School in Chester, Virginia. He played varsity football as a freshman, sophomore, and junior, but sat out his senior year due to a knee injury.

Henderson was drafted by the Green Bay Packers in 1995, and has played every season in his career with the Packers. He came into the league as number 30, but after cornerback Doug Evans left, changed his number to 33.

He is now married to Briggitta Henderson, and has two children, William II and Jayden.

Well, the nation has its very own fight club, in that fight club; are Marcus Carriaga, Leif Kimball. Both enrolled and working with the nation, Marcus Carriaga works with the DNR, as a land specialist. Leif Kimball is a housing inspector, which is located in the labor department. Both are experienced fighters and are currently preparing for their upcoming fights.

"I have always been a fighter" as Leif Kimball says, who has had many fights so far, has overcome so many unhealthy habits, such as losing weight to compete in his last fight, and just having a positive attitude. Focusing on his next fight, he looks to having a great outcome, having many family and friends support him in his quest to become a professional fighter. Leif got into boxing right out of high school, and was later postponed when he began working for the nation, but has resumed his fighting career. He began training with Bobby Bird, Dan Lipke, and "Hammer" Harrison and also a wrestling coach Winter



Smith.

He has gone through training with his teammate and friend Marcus Carriaga, who also is experienced with fighting. Just recently he won a fight not too long ago, in Rockford, Illinois; with a knockout in the second round; he has come off that fight and feels he is ready for his upcoming fight. Carriaga, who is a well experienced fighter, has won three tournaments and awarded with golden gloves trophies, in three different states. This is a trophy, sym-

bolizing that you are a very good fighter.

Carriaga and Kimball are very thrilled to be given a chance like this to compete in a MMA tournament. As they prepare for their upcoming fights they train every single day, pushing pass their limits. Marcus is preparing himself, physically but more important is his mentality; Marcus will be fighting in the catch weight class, which he must weigh in at 185 lbs, but he currently weighs 200 lbs. As for Leif he is also overweight, 280 lbs

the heavyweight class must weigh in at 265 lbs.

has been asked to speak on various panels concerning drunk driving. At first, she turned down the offer because it was difficult, but now she has begun to open up.

"I had to do something. I had to make a difference," she said. "We went to the place when the three died and, standing at the site, I made a promise I would try to do something."

"Remember – we all have those choices and hopefully we can make a difference," she said.

Tamra Oman spoke about the importance of being yourself and positive from a personal and professional perspective. She was an inmate at Taycheedah Women's Correctional Institution in Fond du Lac, but then turned her life around and is currently a human services program coordinator at the Wisconsin Resource Center.

When Oman first entered Taycheedah, she met Melissa Christensen at a table and instantly knew there was something amazing about her, she said.

Oman talked about how she disliked herself and fell into a "very dark place," even not wanting to live.

"I felt so imperfect – all the lies I told, the self-hatred."

She said she was frequently drunk, and was raped and beaten and abused. But instead of seeing what she was doing, she blamed other people.

"I was sitting in prison saying, 'God, if this is all there is, let it end.' You only have this moment – you don't know if you will have a tomorrow," she said.

"The problem wasn't everywhere else. It was within me," Oman said. "Now, I don't want to be anyone else. I have a responsibility to give back wherever I go. I just want you to know that you matter. I thought every day that I didn't."

A person's story is the greatest asset, she said.

"Most of us spend all our time hiding our story," Oman said. "Not one human gets here without help."

She didn't look for successes and based everything on failures.

"Where should it begin? It should begin with me. I want to work in an environment where I find the beauty," she said. "There will always be something that doesn't fit. You can choose the bad things in your life, or the good ones. Which one do you want to feed?"

And people are so sup-

pressed, they don't even properly recognize the good times.

"How do you celebrate successes? We don't take enough time to celebrate successes. Try to support each other," Oman said. "Do you share the good moments? You should make a gratitude list. Look at what is working and celebrate. Also, create a bucket list and check it off – do something. Focus on your gifts in life. And know your role. You can't control everything and you can only do so much."

Melissa Christensen, Ojibwe from Lac du Flambeau, grew up not knowing her role in life and became self-destructive, but she learned a way to become positive and make something of her life.

She remembers when she first arrived in Taycheedah.

"How did life get so bad that I ended up here?" Christensen said. When she was only 9 years old, her mother committed suicide and her father hadn't been much help.

"My dad drank a lot." She took Native American studies in college because she knew nothing about her culture and she felt lost.

"I didn't grow up with culture," Christensen said. She wanted to study engineering, but had her doubts.



"Do I want to travel and be an engineer and be away from my family?" she had asked herself.

Her grandfather was a ricer and trapper. She once met a medicine man who asked her what she needed to do. She said she wanted to help people and then then wind began blowing strongly. The medicine man said the wind is bad spirits who are resisting her.

Her father had an aortic tear in his heart and he needed to get to a hospital during an ice storm. Melissa began to pray and, with much help from

other people, her father did survive the close call. She believes it was the power of prayer that saved him.

"I found out how powerful the Creator is," Christensen said.

In order to turn her life around, she had to find a way to change her internal thoughts from negative to positive. She said that there is a tendency for people to blame their troubles on other people.

"Everyone is blaming everyone. Stop pointing fingers. These are all our problems,"

WTJA president and Forest County Potawatomi Tribal Court Chief Judge Eugene White-Fish and Forest County Potawatomi Tribal Court Associate Judge Chris Daniels were present at the ceremony on behalf of the WTJA.

The staff of the Ho-Chunk Nation Judiciary were also present for the occasion.

Ho-Chunk Nation Trial Court Chief Judge JoDeen Lowe introduced Judge White-Fish to those in attendance. Judge White-Fish explained the WTJA wanted to honor WhiteEagle for her leadership by presenting her a gift.

“The Wisconsin Tribal Judge Association thanks you for leadership. Judge

WhiteEagle served two terms as president of the WTJA.

We talked about who would be nominated to be president. I nominated Amanda and she became the president, and I was the vice president,” said White-Fish.

WhiteEagle stepped down for her position with the WTJA after she stepped down from the bench at the trial court. WhiteEagle now serves as the Ho-Chunk Nation Attorney General.

White-Fish presented WhiteEagle with a Pendleton blanket and an eagle feather for her service to the WTJA.

“Thank you for this honor. I wasn’t expecting anything. It means a lot to me. The organization means a lot to me. The WTJA is looked to nationwide and is on the forefront when it comes to state/tribal relations, handbooks, services offered and training,” WhiteEagle said.

Hocak Worak editor Marlon WhiteEagle and reporter Ken Luchterhand were given the opportunity to learn about methods of communication used by other Native American nations and to improve their own craft and skills.

They traveled to Washington D.C. for the annual Native American Journalists Association (NAJA) convention held in Crystal City, VA, held July 9 through July 12.

The event featured a full schedule of seminars and speakers, concluding Saturday night with an awards banquet.

Opening keynote speaker was Charlie LeDuff, Sault Ste. Marie Tribe of Chippewa, a Pulitzer-Prize winning reporter. He won the prize for his series, “How Race is Lived in America.” He hosts a show on a Fox network affiliate in Detroit, “The Americans with Charlie LeDuff.”

His remarks were about how he continues to reinvent his reporting by telling stories of American life and infusing them with his own vivacity through his writing and on-camera presence.

Another highlight was the speaking engagement of Amanda Blackhorse, a Dine and a member of the Navajo Nation. In June 2014, Blackhorse and

four other Native American petitioners, organized by Suzan Shown Harjo, won their eight-year long case before the Trademark Trial and Appeal Board to cancel federal registrations of the Washington NFL team.

These registrations include the teams’ name and logo. This unprecedented victory appeared to end a more than 40-year battle against the racist name of the team.

One popular seminar was, “Energy in Indian Country,” which discussed how major projects, such as the Keystone XL pipeline, is proposed to go through tribal lands or near them. Meanwhile, fracking in Oklahoma,

North Dakota and other states in the heart of Indian Country also are generating a number of issues for journalists. It provided reporters an idea of data information they should seek for informative stories in covering ongoing energy debates.

Another seminar provided how local tribal events can be recorded and provided to a nationwide network to be aired in several major cities in the United States. The recordings not only inform residents of the information concerning the tribes, but also serve as a means to historically document important events.

# Winneshiek leaves Ho-Chunk Nation position for state job

It was a bitter-sweet time for Sandra Winneshiek.

She was sad to be leaving her job as Veterans Service Officer for the Ho-Chunk Nation, but also she was anxious to begin a new job for the state.

Her last day with the Nation was Friday, July 24, and began her new job on Monday, July 27.

Her new title is Tribal Veteran Program and Services Specialist, a state position with the Veterans Administration with her new office in the Tomah. She's responsible for servicing all the Native American tribes in Wisconsin.

"I make sure all the tribes are up to date with benefit information," Winneshiek said. She is filling the position vacated by Nate Nez, a Navajo,

who retired in February.

The road to her new position wasn't an easy one.

"There were 138 applicants for this job, nationwide," she said. "I think my previous background in working with be veterans' benefits on a national level helped me gain this position."

Sandra is a native of Wisconsin Rapids and enlisted in the U.S. Air Force after high school graduation. Upon completion of her service, she was employed with the Department of Veterans Affairs for more than 24 years.

She also served as the national co-chairman of the American Indian Working Group for Readjustment Counseling Service for 10 years. She was the first woman to hold the position. Her job took her all over the country and allowed her to

assist hundreds of veterans to obtain health, educational and employment benefits.

She was the administrative assistant with the Addiction Disorders Program at the Middleton VA Medical Center in Madison. She left that job to start with the Ho-Chunk Nation on April 23, 2012.

So, now she will be traveling to each of the 11 federally-recognized tribes in the state, initially to introduce herself as the new Tribal Veteran Program and Services Specialist, although all of the Veterans Service Officers already know her. She will tell them about the programs and assist in any way that she can.

"I enjoy working with veterans, I always have. That why I've been working with vets for so long," Winneshiek said.

# Former Trial Court staff attorney to return as Public Defender

After serving as a staff attorney with the Ho-Chunk Nation Trial Court for two years, Noah Lentz took a position with Wisconsin Judicare's Indian Law Office in Wausau, Wisconsin. His new job title: Staff Attorney. Lentz agreed to take the new position within Judicare knowing he'll again be serving the Ho-Chunk Nation tribal members.

Wisconsin Judicare provides access to legal services for low income Wisconsin residents and the 11 recognized tribes.

"There has been a contract between Judicare and the Ho-Chunk Nation to provide legal services to members for over 20 years," Lentz said. "Judicare has primarily done civil cases, like wills, divorces, child protection, guardianships, bankruptcy, elder law and public benefits. We do site visits to each tribe."

"My new position will provide both civil and criminal representation to members of the (Ho-Chunk) nation. I will be the Public Defender for the Ho-Chunk Nation Trial Court when criminal jurisdiction begins."

The Ho-Chunk Nation has enacted a Criminal Code on May 5, 2015. All the procedure are not in place to begin enforcement, but when things are in place Lentz is ready to get to work.

"I'm an employee of Judicare, not of the Nation. If you want me or any other Judicare attorney to represent you in a civil matter, you must apply to Judicare. You can apply online, over the phone, or with a paper application available at the Ho-Chunk Nation courthouse. Before too long, I will also be able to accept application in person, wherever I

happen to be," Lentz said.

"I will be providing criminal defense representation in the Ho-Chunk Nation courts, I cannot represent people in criminal matters in state or federal courts."

Lentz is from northern Minnesota, went to college in Washington D.C. and law school in Minneapolis. He currently lives in Port Edwards.

"While I have worked in marketing and compliance before I started 'general managing' casinos, the most influential job I had was working on the front line with the guests. That's where you find out how the players think."

Decorah said that everyone he has worked with has been special to him in one way or another.

"I learn from everyone.

Sometimes it's just as important to learn 'what not to do' from others, but I've learned that treating people well, while still being honest with them, is the key to being a successful manager," he said.

### 14. Mail Ballot Voting.

a. Mail Ballot Voting.

(a) At the discretion of the Election Board, elections shall be conducted by mail ballot.  
(b) Subject to the limitation provided in Section 14, subparagraph a. (1), the Election Board shall include within its Election Day Guide and Standard Operating Procedures criteria for limiting its discretion as to when an election shall use solely the procedures for poll place voting, which are contained in Section 13, or use solely the procedures for mail balloting, which are contained in Section 14. The Internal Operating Rules shall require that an election be conducted solely using mail balloting or poll place voting.  
(2) Procedures for Mail Balloting.  
(a) The Election Board shall designate a Post Office Box rented by the Board at the place where Ballots shall be returned. Ballots must be received at the Post Office Box designated by the Election Board not later than the day of the Election.  
(b) The Election Board shall send by United States Mail a ballot to each eligible voter or Ho-Chunk Member who will be an eligible voter by the date of the election. The Election Board shall mail ballots forty-five (45) calendar days before the date of the election; and, if said date falls on a weekend, then on the first working day thereafter.  
(c) A Voter may obtain a replacement ballot from the Election Board if his or her ballot is destroyed, spoiled, lost or not received by the Voter.  
(d) The Election Board shall not mail a replacement ballot later than ten (10) working days before the day of an

Election. If pursuant to Section 14, subparagraph a. (3) a voter requests a replacement ballot, the Election Board shall only give a replacement ballot if the request for the replacement ballot is made fifteen (15) working days before the day of the Election.  
b. Ballots. The Ballot package mailed out by the Election Board shall consist of a ballot which otherwise meets the requirements of Section 12, an outer envelope, instruction sheet, ballot secrecy envelope, and return envelope. If the envelope is not signed, the ballot shall be rejected. The entire rejected ballot shall be deposited unopened in a separate, secure box for invalid ballots. If the envelope is not signed, the ballot shall be rejected. The entire rejected ballot shall be deposited unopened in a separate, secure box for invalid ballots. If the envelope is signed, the ballot shall be deposited in the locked ballot box. For ballots placed in the locked ballot box, the Election Board shall make a notation in the poll book, next to the Voter's name, that indicates that the Voter has returned his or her ballot.

c. Multiple Ballots. If a Voter to whom a replacement ballot has been issued pursuant to Subsection a. (2) (c) of this Section votes more than once, only the ballot with the earliest postmark shall be counted. If there are two (2) or more ballots with the same postmark date for one (1) Voter, neither ballot shall be counted.  
f. Security of Ballots. Returned Ballots shall remain in the designated Post Office Box until retrieved by the Election Administrator. The Election Administrator shall retrieve returned ballots on a daily basis and the day after the Election. Upon picking up returned ballots, the Election Administrator shall place the returned ballot in the Ballot Security Box located at the Ho-Chunk Nation Election Board Office. Following the counting of ballots, the Election Board shall maintain returned ballots in a secure location. g. Rejected Ballots.  
(1) The Election Board shall count only the choice(s) which can be determined.  
(2) The Election Board shall keep and retain all partially or completely rejected ballots for a period of at least three (3) years.  
h. Election Results.  
(1) Unofficial results will not be released.  
(2) The Election Board shall determine the official results of the election and shall use the Official Ballot Accounting Form (Election Board Form 5 at Appendix A). The official tallying of the votes shall be open for public observation. The public must remain quiet and in no way interfere with the orderly tallying of the ballots.  
(3) The Election Board shall post the official results on the Official Certificate of Election Results Form (Election Board Form 6 at Appendix A). The Official Certificate of Election Results Form shall be signed by each Member of the Election Board. The Election Board shall post the Certificate at the Polling Places within three (3) calendar days after the date of election.  
(4) After the Election Board has certified the official election results, the Election Board shall retain the election records. These records shall include the counted ballots, the uncounted ballots, and the

spoiled or rejected ballots, if any. The Election Board shall retain the election records for at least three (3) years.

**THE FOLLOWING TERMS ARE TWO (2) YEARS WITH TWO (2) OPENINGS:**

nities through the arts. Throughout the years H.H. Bennett and descendants photographed Ho-Chunk and other tribal performers.

The Reawakened performance will blend the legacy of the ceremonial with the art of pioneer photographer H.H. Bennett complete with the sights and sounds of a multi-media stage production directed by Lance Tallmadge (Ho-Chunk) of Wisconsin Dells. 
