## Ho-Chunk Nation Celebrates New Dual-Language Highway Signs

The Ho-Chunk Nation, state leaders, and community members gathered at the House of Wellness in Baraboo to unveil new dual-language highway signs.

The signs feature both Ho-Chunk and English place names, marking an important step in restoring Ho-Chunk language and visibility across the state.

“Today, we honor our ancestors and celebrate our enduring presence on this land,” President Jon Greendeer said. “These dual-language signs are more than markers along the highway, they are a restoration of our Ho-Chunk identity, our language, and our responsibility to future generations.”

The newly unveiled signs include “Maq Wakacq” (“Sacred Earth”) and “Zaagi ciinak” (“Sauk Village”), with English translations placed beneath the Ho-Chunk language. Each sign also carries the Ho-Chunk Nation seal.

Gov. Tony Evers joined the Nation for the unveiling, highlighting that the work stems from ongoing collaboration between the state and Tribal governments.

“Every dual-language sign we install is a shared decision,” Evers

said. “Wisconsin is strongest when we recognize and respect the people and Nations who have shaped this land for generations.”

The Ho-Chunk Nation became the ninth Tribe in Wisconsin to participate in WisDOT’s dual-language sign initiative, launched in 2021. The program works directly with Tribal Nations to place road signs on Tribal lands in both English and Indigenous languages, an effort that supports language revitalization while also making Indigenous presence visible to the wider public.

WisDOT Secretary Kristina Boardman said the signs are part of a broader commitment to Tribal sovereignty and cultural preservation.

“When travelers see the Ho-Chunk language on these new highway signs, they are reminded that the Ho-Chunk Nation’s resilience and thriving presence will continue to inspire and shape generations to come,” Boardman said.

The unveiling follows other recent collaborations between the Ho-Chunk Nation and the state. Earlier this year,



state and Tribal leadership celebrated the naming of Interstate 90 between La Crosse and Tomah as the Ho-Chunk World War II Code Talkers Memorial Highway, honoring Ho-Chunk veterans whose contributions remained unrecognized for decades.

It also comes after Gov. Evers used his line-item veto authority in the 2025–27 state budget to ensure each of Wisconsin’s 11 federally recognized

Tribes will receive \$1 million per year for the next two years to support Tribal programs, including language revitalization.

“By placing our Ho-Chunk names back onto the landscape,” Greendeer said, “we ensure that our story continues to be seen, spoken, and remembered throughout Wisconsin and along the Mississippi River.”



## Jackson County Sheriff's Office Conveys 'No threats have been found' After Active Shooter Report

On December 9, 2025, at about 10:35 AM, the Jackson County Communications Center received unconfirmed, third-hand information that there was a possible active shooter at the Family Health Center (Black River Falls Dental Center), N6571 Lumberjack Guy Rd., Town of Brockway.

Law enforcement officers from the Sheriff’s Office and the Ho-Chunk Police Department responded to the area and checked all surrounding businesses. No threats have been found at this time and there is no danger to the community. Further information gained indicated that

a neighboring law enforcement agency was conducting a training exercise using a similar scenario. Steps to notify the public prior to the training were taken by that agency.

The initial information was provided by an unofficial online source which was not affiliated with the Sheriff’s Office. Sheriff’s Office information releases would be through official media releases, Nixle messaging system, and our Facebook page.

We appreciate the public’s cooperation and professionalism during the incident response. The Sheriff’s Office was assisted by the Ho-Chunk Emergency Management. This incident is still under investigation.

# Tribal Youth Initiative Makes Strong Start

The Ho-Chunk Nation received a BIA grant last summer to create the Ho Chunk Tribal Youth Initiative, which is intended to introduce tribal youth of high School age to careers in natural resources. This includes wildlife management, forestry, fisheries, soil science and other industries which are important in Wisconsin. The Ho Chunk Departments of Natural Resources, Education (Cultural and Community Education) and Social Services (Youth Services) have combined forces to bring this program to fruition. Three events have already occurred and they were rather stunning successes.

Our first event was a five-hour canoe trip in August down the Black River, which 18 Ho-Chunk youth participated. They received a short paddling clinic from Rick Hengel of Wild Wisco Waters Canoe Outfitters, and then were on their way. We cooked hotdogs on a sand bar, hiked a hidden ravine, and tipped two canoes. One of them twice. Everyone came back safe, tired and happy.

In September ten youth went on a fishing excursion on Potters Flowage in Jackson County. The grant was able to cover the purchase of fishing gear for the youth, and the state DNR waived the need for fishing licenses. It was an unseasonably windy and warm, so the big ones weren't biting. But fish were caught, canoes were paddled (only one tipped) and some fabulous chili was consumed.

Later in September, eleven Ho-Chunk Youth earned their Hunter's Safety Certification. The class was led by Jamie Goodbear and Brandon Bleuer with the assistance of others. We had students come from as far away as Milwaukee to participate. At least one of the students got their first deer this past gun season! The HCN DNR hopes

to have a hunter mentor program in place next season, and we will conduct another class next summer or fall.

There are two events upcoming in the next couple months. On December 29th we will be making a trip up north to the Wittenberg area for our forestry field day. We will be hiking through mature northern forests, in snowshoes if necessary. We will check out some of the planting projects implemented by the HCN DNR and hopefully have a chance to see timber harvest activities in progress.

On January 19th we will have two winter animal tracking events. One will be in the LaCrosse area and one will be at Aztalan State Park. Our staff of experienced trackers will lead students on snowshoes looking for tracks and other animal sign. Students will learn how to tell "animal stories" by what our fellow creatures leave in the snow.

Other future events will be college visits, maple syruping, tree climbing and an overnight camping trip. Stay tuned for more news on these events.

# DNR Urges Caution On Early Ice Covers

## No Ice Is Safe Ice

MADISON, Wis. – The Wisconsin Department of Natural Resources (DNR) encourages all enjoying outdoor fun this season to be extra careful on all of Wisconsin’s waterbodies and remember that no ice is safe ice.

Those eager to take advantage of winter’s snow need to keep safety at the forefront of their preparations. This includes staying alert to the rapidly changing ice conditions commonly found in the early parts of winter.

“Early in the season especially, ice conditions are unpredictable and can change quickly on Wisconsin’s rivers and lakes. The ice covers hide the currents, debris and underground springs still feeding lakes and rivers, thinning the ice in spots,” said Lt. Jacob Holsclaw, DNR Off-Highway Vehicle Administrator. “No matter if you’re on foot, on a snowmobile or in UTV, it’s important to remember that ice is never 100 percent safe.”


The DNR does not monitor ice conditions, but they are monitored locally. Local fishing clubs, outfitters and bait shops are the best sources for local current ice conditions.

However, the best idea for safe winter fun is to enjoy outings without travel over ice. Conditions Vary Between And Across Waters

If the outing does involve travel over a waterbody, remember every waterbody has its own characteristics. Check if the lake has inlets, outlets or narrows, is spring-fed or has currents, all of which can thin the ice.

- Some smaller lakes can have aerators that are run throughout the winter either covering a large area towards the center of the lake or may have smaller aerators placed by private property landowners adjacent to their shore and/or piers.
- Equally as important is to stay alert for pressure ridges or ice heaves. These can be dangerous due to thin ice and open water and often are created, move or grow with changes in temperatures and high winds.
- Here are more safety tips:
- Carry a cell phone, and let people know where you are going and when you’ll return home.
  - Wear proper clothing and equipment, including a personal flotation device or a float coat to help you stay afloat and to help slow body heat loss.
  - Take an extra pair of mittens or gloves so your hands can remain dry and warm.
  - Wear creepers attached to boots to prevent slipping on clear ice.
  - Carry a spud bar to check the ice while

Placement and Respite Homes Needed

Do you have room in your home for children? Are you currently not able to make a long-term commitment for placement of a child? Are you looking to make a difference in the life of a child? Here's your opportunity!

The Ho-Chunk Nation Child and Family Services is looking for respite care providers in all areas near Tomah, Wisconsin Dells, Nekoosa, La Crosse, Green Bay, Wittenberg and Black River Falls. Respite care is short-term care (one day to two weeks) provided to children who are in out-of-home placement. Respite providers are reimbursed \$50 per day per child and are also provided gift cards for food. For emergency respite, the respite rate may be increased. You do not have to be an enrolled tribal member to become a licensed Placement or Respite Home provider!

Respite providers are an integral part of a team of individuals who are looking out for the best interest of children. Relative Placements, Respite Providers and Placement Parents are required to have Federal Criminal Background Checks (fingerprints) (25 U.S.C. "Indian Child Protection and Family Violence Prevention Act").

walking to new areas.

- Carry a couple of spikes and a length of light rope in an easily accessible pocket to help pull yourself – or others – out of the ice.
- Do not travel in unfamiliar areas – or at night.
- Have a plan in place noting where you will be and when you plan to return. Along with leaving a written note of your plans, it is also recommended to keep a charged cell phone.

Take Extra Care With Recreational Vehicles  
Last season, several ATVs, UTVs and snowmobiles went through the ice or drove into open water, resulting in six fatalities.

Keep these safety tips in mind when operating recreational vehicles during winter.

- Remember that UTVs are heavy. They are the heaviest recreational vehicle out on the ice, often being close to 3,000 pounds. This is similar to a car or truck.
- Roll your window down when traveling on the ice and make sure you can easily open you door – drive slow and turn the radio down so that you can use eyes and ears to watch and hear for potential issues coming up.
- Make sure you have life jackets or some other type of floatation for every occupant of the UTV.
- Recovery for the UTV or other vehicle is the responsibility of the owner/operator. After 30 days, the owner can be fined each day after 30 days.
- Recovery rates for the machine can also be very expensive.
- Never consume alcohol or drugs before or during your ride.

Refer to the Wisconsin Snowmobile Regulations for laws for operational restrictions, safety tips and more.

The DNR also encourages all snowmobilers to take a safety education class. According to Wisconsin law, anyone at least 12 years of age and born after Jan. 1, 1985, must have a valid safety education certificate to operate a snowmobile. Sign up now as classes fill fast.

If the worst happens and you happen to fall in, here’s what to do:

- Carry a couple of hand-held spikes and a length of light rope in an easily accessible pocket or inside your sleeves to help pull yourself – or others – out of the ice.
- If you fall in, remain as calm as possible and while attempting to assist yourself out of the water, call for help as soon as you can. Anyone who attempts to rescue you also is recommended to use a rope or something similar to avoid falling through as well.

### Address Change

When you apply for Elder Insurance, please include an Email and Phone Number.

Please notify Gloria Ward or Sara Pomeroy in the insurance department with address changes.

If you changed it with Enrollment or Treasury you must also change with Insurance. This will allow Insurance to send notifications that are required.

We will be doing Medicare Reimbursement again for Elders 65 and older that pay for their Medicare B. If your address has changed, please call, mail or email us as soon as you can to change it.

You will get an application in January to send back before 3/31/26

### Insurance Cards

If you utilize an ambulance, you must give them a copy of your Insurance and Medicare cards, the hospital does not share information with them.

### Medicare Parts A and B

If you are working Part Time, LTE or an Elder worker for the Ho-Chunk Nation you carry both parts Medicare A and B.

If you are working for the Ho-Chunk Nation full time and your turning 65 you don’t have to sign up for Medicare Parts A and B until you retire, resign or are working part-time.

Please supply us with a copy of your Medicare A and B card for our records.

Failure to sign up will result in consequences. The plan will only pay 20% of your bill and you will be responsible for 80%.

You do not need anything other than **A** and **B**, you don’t need **D** it is for Prescriptions you have that coverage with your Elder Insurance.

If you need help signing up for Medicare A & B please contact Melissa Deloney (715-284-0811) at TAU or Gloria Ward in the insurance department.

If you’re drawing Social Security your payment for Medicare B will come out of your check.

# Submerged Canoes in Lake Mendota Offer New Insights into Ancestral Traditions and Waterways

*With 16 canoes now identified, Wisconsin Historical Society archaeologists are investigating theories spanning thousands of years of cultural history*

MADISON, Wis. – Four years after locating and recovering a 1,200-year-old dugout canoe from Lake Mendota, Wisconsin Historical Society archaeologists and First Nations in the region have continued to wade into the history of the rich archaeological site in the heart of Wisconsin’s capitol city. The Wisconsin Historical Society retrieved another ancient canoe from the site in 2022—the oldest dugout canoe originating from the Great Lakes region at the time of recovery at 3,000 years-old—and has since identified 14 ancient canoes still submerged in the lakebed, six of which were located in the spring of 2025. As the two recovered canoes are nearing completion of a multi-year preservation process to ensure their long-term stability, with one of them slated for exhibition in the future Wisconsin History Center, historians are investigating the history behind the underwater site to help preserve and share the story with future generations.

Latest Findings

Wisconsin Historical Society maritime archaeologist Tamara Thomsen, in partnership with First Nations of Wisconsin and University of Wisconsin-Madison professor Sissel Schroeder, has been on a mission to chart the locations of more canoes in Lake Mendota since her unexpected finding of a 1,200 year-old dugout canoe in 2021. Working alongside various collaborators also including the USDA Forest Products Laboratory, efforts have allowed her to map the locations of 16 canoes to date, including the two retrieved in recent years, and identify the wood types and probable ages represented in samples taken from each of the ancient watercraft. Thomsen is now considering theories behind the grouped positions of the canoes as well as the selection of particular species of trees used to craft them.

“Archaeology is kind of like putting together pieces of a puzzle, and the more pieces you can find, the better you can start to form a picture of what was going on and why during

a period of history,” said Tamara Thomsen, Wisconsin Historical Society Maritime Archaeologist. “We can’t go back in time to get answers to our questions, but we can examine the available data alongside knowledge from First Nations and cultural history to form theories to answer our questions.”

Of the 16 canoes identified, half were constructed of either red or white oak according to wood type analysis conducted on the samples by the USDA Forest Products Laboratory. The prevalence of oak—and particularly red oak, which is not typically used for watercraft due to its tendency to absorb water—prompted Thomsen to examine the reasoning behind its use for canoe building.

“When you look at the shoreline map with canoe locations charted, it’s clear that there are two distinctive groupings represented,” said Thomsen. “Looking at the tree species taxonomy, we wondered not just why certain trees were used by the builders but also why these canoes were situated in

these two locations. Carbon dating from the samples told us that both spots were in use over thousands of years, and so we started to form theories as to why they were left where they were and why certain trees were used.”

Carbon dating, which provides a probable age range for each sample, indicates the oldest canoe is around 5,200-years-old while the most recent is around 700 years old. The oldest Lake Mendota canoe identified to date was likely crafted sometime around 3000 BCE, before the Great Pyramid of Giza was built in Egypt and around the time of the invention of writing in Sumer. Constructed of red oak, it is now the oldest dugout canoe recorded from the Great Lakes region and the third oldest in eastern North America.

Emerging Theories

Oak wood, along with some of the other species represented in the samples, is known to form tyloses when the tree encounters stress during the growth cycle such as through wounding or pathogen

infection. Tyloses also form as a natural part of a tree’s aging process. During the production of tylosis, balloon-like structures form inside of the wood’s vessels which blocks water movement—preventing the spread of fungi and bacteria and compartmentalizing injuries to protect the wood from decay. As a result, the tyloses make the wood better suited for boat building due to its increased water resistance, buoyancy and protection against rot.

“It’s entirely possible that the canoe builders were intentionally selecting trees that had been damaged from weather or purposefully wounding them during their growth cycle to induce tyloses. We think of bioengineering as a modern practice, but the samples we have suggest this may have been taking place long before the term was coined in the mid-20th century,” said Thomsen.

As for the centralization of canoes into two distinct groupings, a comparison against mapped trailways used by Indigenous

Pumpkin Seeds (Suu)

About Pumpkin Seeds:

- Indigenous people used nearly every part of the pumpkin plant. Some tribes used the seeds as medicine, or dried / roasted the seeds as an important source of protein and healthy fats. Some tribes ground the seeds into flour and mixed it with cornmeal to make breads.
- Nowadays, pumpkin seeds can be eaten with or without their shells. After you scoop them out of the pumpkin, it's a good idea to soak them in water for a few hours to make it easier to remove the pulp. Eating the shells adds extra fiber, which may help lower the risk of heart disease and obesity.
- Pumpkin seeds are an excellent natural source of magnesium, which helps regulate blood pressure. They also provide a variety of other minerals, protein, fiber, and healthy fats.

PUMPKIN SEEDS  
RECIPE

Ingredients:

- 2 cups pumpkin seeds (cleaned)
- 2 tsp olive oil
- ¼ tsp salt
- ¼ tsp garlic powder

Steps:

- Wash hands before getting started.

# Ho-Chunk attorney Samantha Skenandore on tribal law and sovereignty

Samantha Skenandore once planned to be a veterinarian. Today, she is a founding partner at Madison, Wisc.-based Skenandore Wilson LLP, specializing in tribal law and governance.

A member of the Ho-Chunk Nation (also a descendant of the Oneida Nation), she found her path to law through an unexpected route: working with Ho-Chunk tribal elders in the nation’s cultural resources division after graduating from the University of Wisconsin. When a bottling company threatened a sacred spring site, she saw firsthand how legal advocacy could protect tribal sovereignty and cultural resources.

She earned her law degree from University of Denver Sturm College of Law in 2005 and clerked at the U.S. Department of Justice. Since then, she has advised dozens of tribal and corporate clients on governance, economic development, labor law and cultural-resources protections.

Skenandore fostered and later adopted three daughters, while building her legal career as a single mother. She spoke with Tribal Business News about access to legal services, the importance of learning from other tribal nations and why she tells young professionals: “You can be anywhere you want to be.”

*The conversation has been edited for clarity and brevity.*

**What drew you to working in professional services, and how did you find your way into this role?**

Originally I wanted to go to vet school. I thought I could work with kids in behavioral sciences, maybe be a counselor, or work in law in private practice or for my tribe as an in-house attorney. I finished my degree at the University of Wisconsin, and luckily landed a job in the Historical Preservation Department of the Ho-Chunk Nation, in the Cultural Resources Division—a group of mostly elders working to protect sacred sites and the language.

While I was there, a watchdog nonprofit called the tribe about the Perrier Bottling Company,

which had support from the governor to open on a sacred spring site. I learned from the attorneys, tribal council, and elders how to stand firm and fight it. After that... I realized I had enough to take the LSAT and go to law school, to advocate for not just Ho-Chunk, but other tribes... because therein lies my real passion.

**Why do tribes, tribal enterprises, or Native entrepreneurs hire you? What do they expect from someone in your field?**

What I do is help them figure out their goals, and then translate those goals into action and results. It is really about getting outcomes that matter to them.

**Can you share one project or client experience you’re especially proud of — what did it involve, and why was it important for the client or community?**

I do pro bono work on domestic violence — I’ve done dozens of cases throughout Indian Country and state courts. I’m very proud of the work and how the outcomes have affected children in particular. I will say, if I could pinpoint a recent thing I am proud of — I joined the board of Bioneers, a nonprofit focusing on social change. They hired me to come up with a legal toolkit for tribes to pass rights of nature laws, which are in the avenue of tribal sovereignty.

**What are the biggest challenges you see Native communities facing in your area of expertise?**

I think one of the biggest challenges is access—access to legal resources, access to advocacy, and just navigating systems that weren’t built for Native communities... figuring out how to bridge that gap and make sure people have the tools and support they need.

**What’s the secret to hiring Native professionals in your industry — what should tribes or entrepreneurs look for?**

I can’t understate the importance of conferencing and togetherness and sharing, and that’s how we learn. We still have the same ways of doing business that we did 30,000 years ago - they have just changed a little bit. People need to go, listen and ask questions - learn from other

nations and look through some other lenses and perspectives.

**What advice do you have for individuals looking to enter the industry?**

I’m no tribal leader—I’m just the help. But from the help’s perspective, I would say: stay active. You can be the help, you can be a leader, or you can be somewhere in between. Maybe you’re on the school board, or maybe you’re working with youth—autistic kids or kids with special needs—and helping lift them up. All of these contributions make our communities stronger when youth can find their pathway within the vast fabric of our kinship and tribal communities. And I think that’s a beautiful thing.

So my advice is this: know that you belong, and there are spaces for you everywhere. Don’t ever let anyone convince you otherwise. You can be anywhere you want to be, and I truly believe that. And if you don’t think it’s true, call me — I’ll help you get there.

communities suggests strategic placement for ease of travel over the landscape, not just for accessing natural resources from the lake but also to facilitate journeys between points of interest on land. The canoes were likely not owned by individuals, but rather shared among members of communities and stored at designated points, similar to how modern community bike sharing programs utilize docking stations for users to store bikes between riders.  
“The canoes give us insight into a sophisticated travel network and interconnected communities who used their incredible skills and knowledge to live and thrive on lands where we still live and thrive today. They reflect a deep relationship with the environment and the ingenuity of our ancestors,” said Larry Plucinski, Tribal Historic Preservation Officer, Bad River Band of Lake Superior Chippewa. “Sharing what we learn from this project honors the

innovators whose knowledge lives on and inspires new generations to feel pride for their ancestors.”  
The canoes could facilitate access to natural resources from the lake like fish—as suggested by the seven net sinkers found with Canoe #1 and three found with Canoe #13—but could also make travel more efficient between communities for trading and to access places of spiritual importance, such as Lake Wingra. The landscape around Madison lakes looked very different before European settlers arrived in the area and conducted terraforming to suit modern transportation, with large bluffs that made traveling over the land difficult in some areas. Canoe travel may have been more efficient for certain routes for the communities who lived in the area spanning thousands of years before Wisconsin became a state.  
“Lake Wingra holds deep spiritual significance for the Ho-Chunk people, whose ancestral lands surround its shores,” said

Dr. Amy Rosebrough, State Archaeologist for the Wisconsin Historical Society. “One of its springs, with its white clay bottom, is viewed as a portal to the spirit world. For generations, the Ho-Chunk have honored this place through ceremonies of remembrance, guidance and peace, helping spirits journey to the world beyond. This lake is not just a natural feature but a place of profound cultural and spiritual connection.”  
“This project gives us a meaningful opportunity to gain a deeper perspective on our heritage and our ancestors. The canoes remind us how long our people have lived in this region and how deeply connected we remain to these waters and lands,” said Bill Quackenbush, Tribal Historic Preservation Officer, Ho-Chunk Nation. “It is important that we document and share these stories so our youth feel that connection to our past. Protecting and preserving this knowledge ensures that the next generation

understands where we come from and why these stories matter. That is why we share them and continue this work.”  
Grant Funding  
While working theories shed light on the why and how of the Lake Mendota canoes, the Wisconsin Historical Society continues to work in partnership with First Nations in Wisconsin to document the story for future generations while taking steps to ensure the two recovered canoes are preserved and protected from degradation. In September, the Society was awarded a \$113,912 grant from the Save America’s Treasures grant program of the National Park Service, Department of Interior, for canoe preservation.  
Both recovered canoes have undergone initial steps of a preservation treatment that uses Polyethylene Glycol (PEG) to stabilize the wood. The treatment began in February 2024 and is expected to conclude next year, but the canoes need to be transported from

Wisconsin’s State Archive Preservation Facility in Madison to Texas A&M University to undergo a freeze-drying process that finalizes their preservation and leaves the canoes in a stable, solid structure. The grant will support safe transport of the canoes to the freeze-drying facility so the preservation process can be completed.  
“The recovery and preservation of the Mendota canoes is a remarkable achievement made possible through the dedication, expertise and strong partnerships between First Nations, archaeologists and preservation specialists,” said Christian Overland, Ruth and Hartley Barker Director & CEO of the Wisconsin Historical Society. “Thanks to this collaboration, we are excited about the learning opportunities and that one of these incredible canoes will be exhibited in the future Wisconsin History Center, where it will help share the stories of our state’s earliest peoples.”

Phyllis Smoke stated that this Resolution is a request to the Election Board to conduct a Secretarial Election to amend the HCN Constitution, to add language that reflects the policy direction of General Council Resolution 09.16.2023-G, which was adopted in 2023 and entitled “Resolution to Modify Blood Degree of Each and Every Person of Ho-Chunk Nation Indian Blood who was Duly Enrolled in the Ho-Chunk Nation on December 31, 1999, will now be considered a Full-Blood, or 4/4 Blood Degree.” Rep. Phyllis Smoke mentioned a few points about this GC Resolution:

- The 2023 GC Resolution did not ask the Legislature to seek a Secretarial Election

- Rather, the GC Resolution mandated that the Legislature change the Enrollment and Membership Code to reflect the change to 4/4 blood degree

- The Attorney General issued an Opinion finding that this change to the Enrollment Code could not be done, without violating the HCN Constitution.

- The Attorney General indicated that the Constitution would have to be amended first, to allow for such a change to be implemented.

In light of constitutional concerns, the Legislature did not take the action outlined in the 2023 GC Resolution. Rather, the Legislature adopted Resolution 10.31.23P, acknowledging the GC Resolution and referring it to a Legislative Workgroup to review the impacts of such an enrollment change on the Nation’s finances and programs. The Legislative Workgroup did discuss this and even went through an RFP process to select a vendor to do demographic and impact research. Although a vendor was unofficially selected, no contract was entered into. Thus, the effort was stopped.

Rep. Phyllis Smoke continued with points about the proposed Legislative Resolution/Request:

- The Request asks the Election Board to conduct a Secretarial Election to amend the Constitution, at a meeting of the General Council. This is an option under Section 21.e(3) of the Election Code.

- The Request is made pursuant to Article XIII, Sec. 2 of the Constitution. Here, the Legislature does have the right to make such a request to the Election Board. Two-thirds of the entire Legislature must approve such a request.

- The Request is also made under Section 21.c and 21.e(3) of the Election Code. The Code request that the actual text of the proposed amendment be stated in the Legislative Resolution. (This is on page 3 of the Legislative Resolution.) And the Certification must list the full vote total of the Legislature, indicating who was in favor, opposed, or abstained.

- The Request must also specify how the Secretarial Election should be conducted (i.e., mail ballot, in conjunction with a General Election, or in conjunction with an Annual GC meeting). Here, it has been drafted to be at the same time as a GC meeting.

Rep. Phyllis Smoke noted one correction to the Resolution in front of the Legislature today would be to add that the secretarial election would take place at the 2026 Annual General Council Meeting.
